

Privacy and Personal Data Protection Policy

This Privacy and Personal Data Protection Policy applies to information containing personal data of third parties interested in participating in organized events, as well as purchasing goods, works and services of the Contractor (hereinafter referred to as the User), which the Internet resource <https://devopsdays.uz> (hereinafter referred to as the Site) may receive about the User during their use of the Web resource.

1. Definition of terms

- 1.1. **Personal data** – information recorded on electronic, paper and (or) other tangible media related to a specific individual or enabling their identification.
- 1.2. **Non-personal data** – information that is automatically transmitted during the User's viewing of advertising blocks and when visiting pages on which the system's statistical script is installed: the address of the requested page, cookie information, IP address, browser information, referrer (address of the previous page), access time.
- 1.3. **Collection of personal data** – actions aimed at obtaining the User's personal data.
- 1.4. **Processing of personal data** – implementation of one or a set of actions to collect, systematize, store, modify, supplement, use, provide, distribute, transfer, depersonalize and destroy personal data.
- 1.5. **Protection of personal data** – a set of measures, including legal, organizational and technical ones, carried out for the purposes established by the Law of the Republic of Uzbekistan "On Personal Data".
- 1.6. **The Website** is a web resource located on a server in Almaty and having the Internet address <https://devopsdays.uz>, which presents the goods/services offered to Users for placing Orders, as well as the terms of payment and delivery of these Orders to Users.
- 1.7. **Website services** – all services available for use on the Website and its subdomains.
- 1.8. **User** – a visitor to the Website.
- 1.9. **Seller** – IP "ISMATOV BOBIR TOXIR O'G'LI", which is the owner of the Website, IIN: 604195901
- 1.10. **Cookies** are small text files in which the browser records data from the websites visited by the User. Cookies perform a number of functions, for example, they allow the User to effectively navigate between pages, remembering his preferences, and thus improves the experience of interaction with the Website. They can also help ensure that the advertising that the User sees online matches his interests. If you do not use cookies, it will be impossible to buy a product on the Site at all, since the entire operation of the shopping cart is based on saving data from these files. For example, if the User selects a product on the Site, puts it in the shopping cart and goes to a new page, this product will simply not be saved in the shopping cart.
- 1.11. **IP address** is a unique network address of a node in a computer network built using the IP protocol, allowing you to determine the location of the User. The Site does not track location, in more detail than the city and region.

2. General Provisions

- 2.1. This Policy sets forth the Contractor's obligations to maintain confidentiality and ensure protection of the privacy of personal data that the User provides at the request of the Contractor upon registration on the Site and/or when placing an order for the purchase of goods, works and services.
- the User's last name, first name, patronymic (patronymic, if any);
 - User's contact telephone number;
 - Email address;
 - Address for delivery of goods, performance of work and/or provision of services.
- 2.2. Personal data permitted for processing within the framework of this Policy are provided by the User by filling out the registration form on the Site and include the following information:
- 2.3. Any other personal information not specified above (purchase history, browsers and operating systems used, etc.) is also subject to secure storage and non-dissemination, except for the cases provided for in paragraph 4.3.2. and paragraph 4.4. of this Policy.

3. Purposes of collecting and processing personal data

- 3.1. The Contractor collects, processes and stores only those personal data that are necessary for the provision of Services and/or the purchase by the Buyer of goods, works, services from the Site catalog.
- 3.2. The Contractor uses the User's personal data for the following purposes:
- 3.2.1. идентификации Пользователя для оформления заказа и/или заключения гражданско-правового договора;
 - 3.2.2. обработки и получения от Пользователей платежей;
 - 3.2.3. доставки товара, выполнения работы, оказания услуги;
 - 3.2.4. предоставления Пользователю эффективной клиентской поддержки;
 - 3.2.5. предоставления Пользователю персонализированных Сервисов сайта;
 - 3.2.6. связи с Пользователем, в том числе направление уведомлений, запросов и информации, касающихся использования Сервисов, оказания услуг, а также обработки запросов и заявок от Пользователя;
 - 3.2.7. улучшения качества Сервисов, удобства их использования, разработка новых Сервисов и услуг;
 - 3.2.8. информирования Пользователя о проводимых мероприятиях и акциях;
 - 3.2.9. проведения статистических и иных исследований на основе Неличных данных, а также оптимизации рекламных сообщений.
- 3.3. The Contractor is not responsible for the information provided by the User on the Site in a publicly available form.
- 3.4. The Contractor is not responsible for any losses that the User may incur as a result of his login and password becoming known to a third party.

4. Rights and obligations

- 4.1. The User is obliged to:
- 4.1.1. provide information and personal data necessary for using the Site;

- 4.1.2. Update information and personal data provided to the Contractor, at the request of the Contractor within 3 (three) days from the date of receipt of the request with the provision of supporting documents;
- 4.1.3. change, supplement the information provided in case of detection of incorrect data when using the Site.
- 4.1.4. Give the Contractor consent to the processing of personal data
- 4.2. The User has the right:
 - 4.2.1. to access and edit information about personal data at any time by contacting the e-mail address tashkent@devopsdays.org.
- 4.3. The Contractor is obliged to:
 - 4.3.1. use the received information and personal data exclusively for the purposes specified in Section 3 of this Policy;
 - 4.3.2. ensure that confidential information and personal data are kept secret, and not disclose the transferred personal data without the prior written permission of the User, with the exception of the transfer of data for the purpose of fulfilling the User's order (courier services, postal organizations, banks, etc.), as well as authorized state bodies of the Republic of Uzbekistan in the manner established by the legislation of the Republic of Uzbekistan;
 - 4.3.3. take precautions to protect the User's personal data in accordance with the procedure usually used to protect this type of information.
- 4.4. The Contractor has the right to provide access for the collection and analysis of Non-Personal Data of Users to third parties for the purposes of statistics and optimization of advertising messages. The use of Non-Personal Data by third parties is governed by their own privacy policies, and the Contractor is not responsible for their use.

5. Final conditions

- 5.1. By using the Site you agree to this Policy and the terms of processing the User's personal data.
- 5.2. In case of disagreement with the terms of the Policy, the User must stop using the Site.
- 5.3. This Policy applies only to the Site and subdomains. The Contractor is not responsible for third-party Internet resources that the User can access via links available on the Site.
- 5.4. Due to the specific nature of the method of obtaining information and personal data, the Contractor does not check their accuracy and does not monitor their relevance. However, the Contractor assumes that the User provides accurate personal data and confirms their relevance. The User bears all responsibility, as well as possible consequences for providing inaccurate or outdated personal data.
- 5.5. Disabling Cookies may result in the inability to access parts of the Site that require authorization.
- 5.6. The Site collects statistics on the IP addresses of its Users. This information is used to identify and resolve technical problems, to monitor the legality of financial payments and transactions.
- 5.7. The current legislation of the Republic of Uzbekistan shall apply to this Policy and the relations between the User and the Contractor.

- 5.8. The Contractor reserves the right to unilaterally change this Policy for the further improvement of the protection and security system in accordance with the current legislation of the Republic of Uzbekistan.
- 5.9. All suggestions or questions regarding this Policy should be reported to the address: Republic of Uzbekistan, Tashkent city YASHNOBODSKY DISTRICT, Obisher 1-berk 16.
- 5.10. The Contractor shall not be liable for the actions of third parties who have gained access to information about the User as a result of using the Internet, for the consequences of using information that is available to any user of the Internet.
